I express my intention to take responsibility for leading the personnel of the Udomporn Subdistrict Administrative Organization in adhering to the fundamental principles of the nation, namely Nation, Religion, Monarchy, and Democratic Governance with the King as Head of State. I will conduct myself professionally, lead by good example, stand firmly for what is right, prioritize public benefits over personal interests, and perform my duties with fairness.

I solemnly declare that I will follow the example of His Majesty the King, act in accordance with His vision, live a life of sufficiency with perseverance, and stand alongside honest people for the stability and sustainability of the Kingdom of Thailand forever.

Udomporn Subdistrict Administrative Organization Announcement

Subject: Policy on not accepting any kind of gifts for the performance of duties.

This provide is intended to provide effective administration of the Udomporn Subdistrict Administrative Organization, Fao Rai District, Nong Khai Province. It is about enhancing culture and values, following the guidance "Honesty, Transparency, and Accountability" In performing work morally and ethically, there should be no special benefits; preventing corruption that may occur in an organization should be of utmost importance.

At the Udomporn Subdistrict Administrative Organization, therefore, a policy was established to refusal to accept any kinds of gifts and presents while performing duties, as follows:

1. Subdistrict employees, hired employees, employees, and all officials of the Udomporn Subdistrict Administrative Organization should refrain from accepting gifts and all kinds of presents related to the performance of duties from outsiders or other people who come to contact with government officials.
2. Subdistrict employees, hired employees, employees, and all officials of the Udomporn Subdistrict Administrative Organization should refrain from giving gifts and all kinds of presents related to the performance of duties to outsiders or other people who come into contact with government officials.
3. Subdistrict employees, hired employees, employees, and all officials of the Udomporn Subdistrict Administrative Organization should not seek to obtain gifts, gratuities, or other unlawful benefits.
4. Methods of expression such as congratulations, expressing good wishes, extending a welcome and expressing condolences, on various occasions according to tradition, should be done by signing greeting cards, greeting books, or condolence cards or using online media, instead of giving away things.
5. Subdistrict employees, hired employees, employees, and all officials of the Udomporn Subdistrict Administrative Organization have a duty to inform outsiders of such policy thoroughly.
